
2010 AGM Notice of Motions - Results

1. WHEREAS: The current Rural and Urban, Junior Varsity Volleyball and Basketball Provincial Championships group all categories of schools together;

AND WHEREAS: Junior Varsity category is based on grades, rather than school population;

AND WHEREAS: Varsity Volleyball and Basketball have distinct school population categories such as A, AA, AAA and AAAA to ensure equitable competition;

AND WHEREAS: High School Hockey Provincials are already separated between "A-AA" and "AAA-AAAA" categories, which recognizes the differences between school populations;

BE IT RESOLVED THAT: The JV Volleyball and Basketball Provincial Championships be changed to A-AA JV Provincial Championships, and AAA-AAAA JV Provincial Championships.

RATIONALE: This would allow more schools to have an opportunity to compete against schools with similar populations

RATIONALE: The following proposal would not add any championships or banners to MHSAA championships, only minor changes in the qualifying and hosting process would be necessary.

2. WHEREAS when the "AAA" Basketball Championship format was increased to 10 teams from 8,

AND WHEREAS the number of "AAA" schools that compete in Basketball has been reduced due to changing school enrollments. (In 2010 there were registered 27 Boys and 28 Girls Teams in comparison to AA at 33 boys and 30 girls teams)

AND WHEREAS the AAA category is the smallest one that MHSAA provides Championships for.

AND WHEREAS, the current 10 team format is unbalanced, and does not meet the needs of changing the Championship, a few years ago, to a 3 day tournament so that ALL teams play 1 game per day.

BE IT RESOLVED THAT the MHSAA revert to an 8 team boys and 8 team girls for the AAA Basketball Championship

AND BE IT FURTHER RESOLVED that this take effect 2010- 2011 season.
